The Wiltshire Council Castle Combe 7 and Yatton Keynell 25 Diversion and Definitive Map and Statement Modification Order 2023

Northern Area Planning Committee Meeting 22nd January 2025

Following the making of the above-mentioned order, I am writing to advise you that Wiltshire Council are in receipt of 7 objections to the order, which have not been withdrawn. The order now falls to be considered by the Wiltshire Council's Northern Area Planning Committee, whose members will consider the objections received against the legal tests for the making and confirmation of a public path diversion order, as set out under section 119 of the Highways Act 1980 in order to determine whether or not Wiltshire Council continues to support the making and confirmation of the order. If members determine that Wiltshire Council support the confirmation of the order it will be forwarded to the Secretary of State for determination.

The matter is provisionally scheduled to be considered by the Northern Area Planning Committee at their meeting to be held on **Wednesday 22nd January 2025** commencing at 15:00, the venue is Town Hall, High Street, Chippenham, SN15 3ER.

This item has not been confirmed as being considered at the above mentioned meeting at this time, however, to give all parties as much notice as possible this letter is being sent on the premise that the meeting will proceed, and the item will be considered at the meeting scheduled for 22nd January 2025. If no further communication is received please assume the meeting is proceeding at the time and date stated and the diversion order will be considered at that meeting. If the meeting is deferred I will make further contact to inform you of this decision. Please contact Democratic Services (committee@wiltshire.gov.uk) for more information.

Details of the committee can be found on Wiltshire Councils website at www.wiltshire.gov.uk/planning-committee-meetings-calendar and then navigate to the northern area and click on the scheduled meeting on 22nd January 2025 at 15:00. This link should have the most up to date information regarding the committee meeting.

I understand that the agenda and report will be published shortly before the meeting, (generally about 5 days before the meeting) and may be viewed on the Wiltshire Council website using the web address given in the previous paragraph.

Public participation at the meeting is possible and members of the public who wish to speak either in favour or against the agenda item are asked to register to do so not later than 2.50pm the day of the meeting. If you would like to register to address the committee, please contact Democratic services using the email address committee@wiltshire.gov.uk.

The Chairman will normally allow up to 3 speakers in favour and up to 3 speakers against an item. Each speaker will be given up to 3 minutes to speak. Speakers from the Parish Council are in addition to the above and are given up to 5 minutes to speak.
